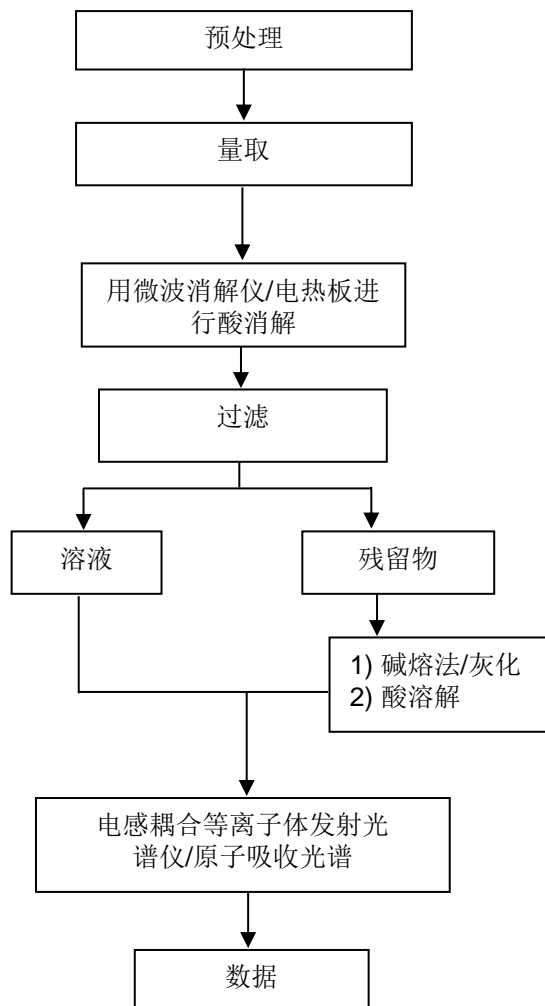

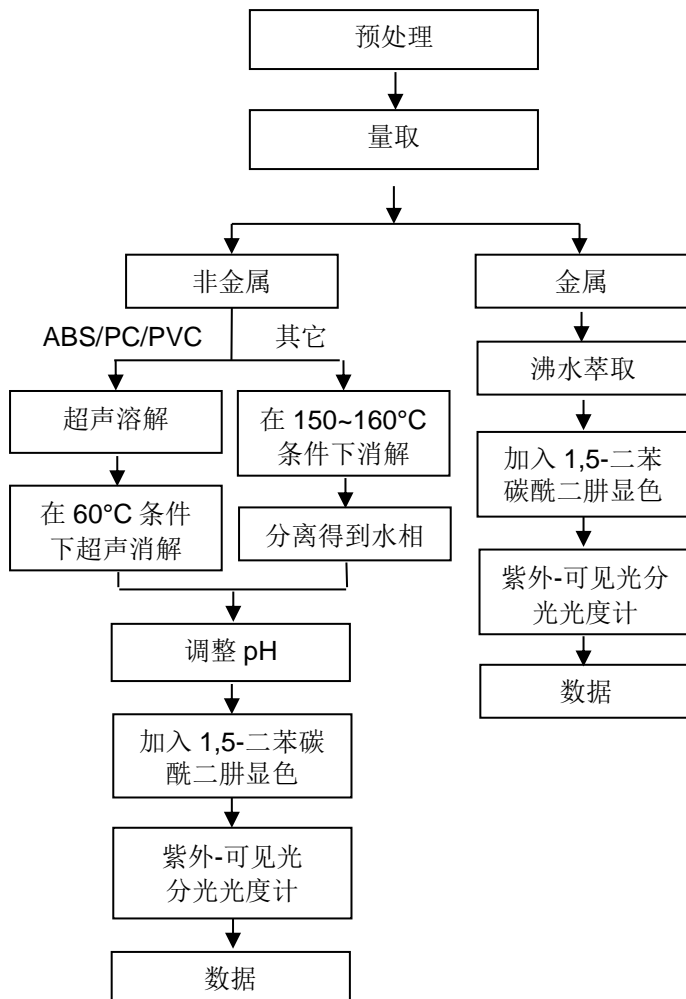

六价铬检测流程图

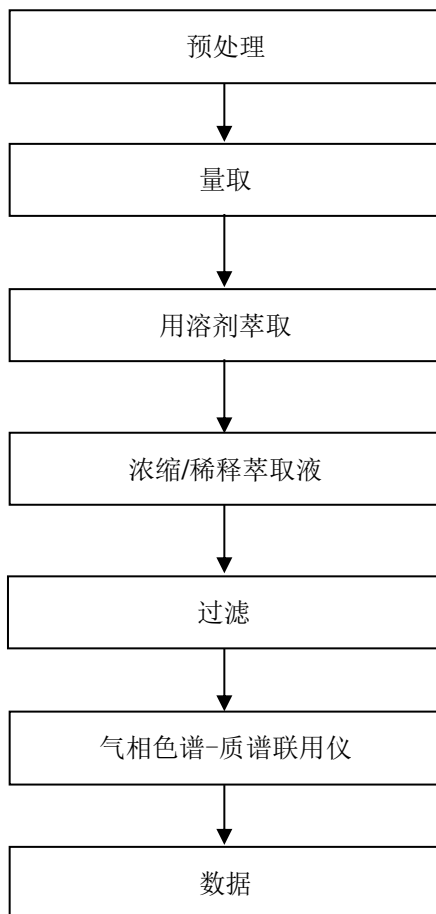

PBB/PBDE 检测流程图



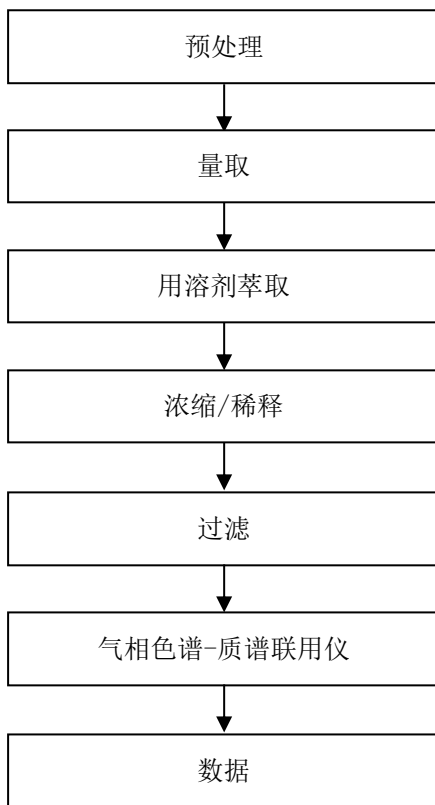

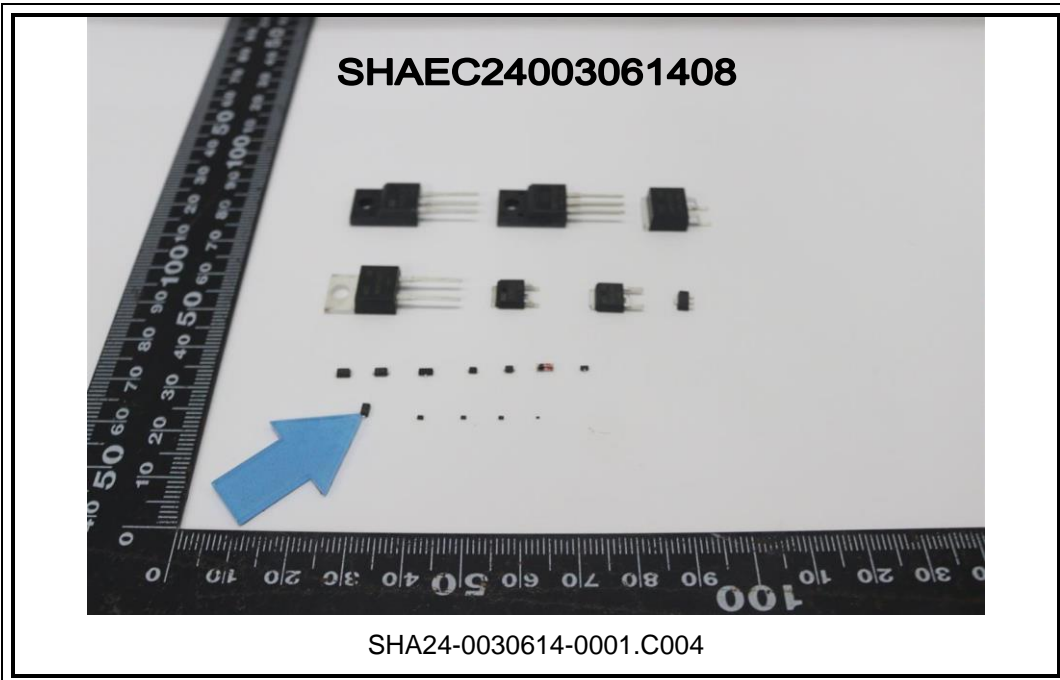
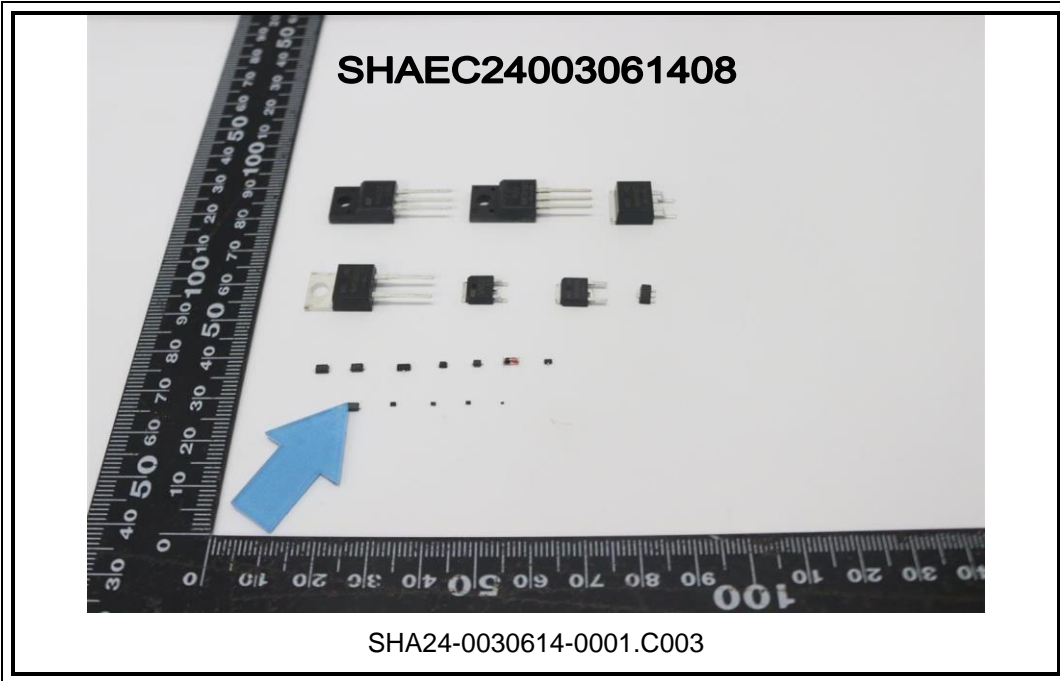
